THE MAIN OUTCOMES OF THE NATIONAL CONSULTATIONS

Regarding the key component "Recovery from Covid-19 disruption":

- development of socio-emotional skills of students in the system of general secondary, vocational and secondary specialized education of the Republic of Belarus;
- improvement of digital competence of teachers and educators;
- development of innovative educational digital products;
- updating of computer equipment in educational institutions.

Regarding the key component "Transformation of education":

- formation of students' competencies and skills necessary for conducting inventive, innovative, entrepreneurial activities, creating innovative products and commercializing the results of intellectual activity;
- development of an innovative infrastructure of university science, increasing the effectiveness of research activities in institutions of higher education;
- development of youth entrepreneurial activity, including support for youth start-ups and volunteer activities;
- updating the content of educational programs, ensuring the variability and flexibility of curricula for advanced training and retraining;
- ensuring an appropriate level of security for educational institutions;
- prevention of asocial manifestations, countering crime and delinquency among young people;

Regarding the key component "Review of national education targets and benchmarks":

- development of scientific and methodological support for the formation of functional literacy of students;
- improvement of educational book publishing and development of electronic educational resources for general secondary education;
- advanced training of personnel for innovative high-tech industries, including through the opening of new specialties;
- expanding the professional training of people with disabilities;
- updating the content of educational programs, developing educational standards of a new generation, taking into account the trends in the development of the economy, society, and the requirements of employers;
- creating of a barrier-free environment for people with disabilities;
- ensuring effective socialization of young people in difficult life situations, including the development of various forms of professional rehabilitation and adaptation;
- strengthening the human resources potential of universities, rejuvenation and professional development of the teaching staff;

Regarding the key component "Ensuring sustainable public financing":

- increasing educators' salary;
- development of economic independence of educational institutions;
- deepening the independence of educational institutions both in matters of planning and managing budget funds;
- development of innovative financing and expanding fiscal space.
