The Ministry of Education and Science (MoES) had assumed the role of the lead agency (i.e. convenor) and was continuously supported by RCO and UNICEF (LEG Co-Chair) to make sure that consultations are fully aligned with Guidelines and participants of the regioal and national consultations (in each of the four locations) inlanched representatives of the Ministry of Education and Science and its subardinate government agencies/bodies, Ministry of Economic developement and Trade, ministry of Finance, local education departments (at subnational level) local municipalities, management of educational institutions (state/private kindergartens, early chilhood education centers, schools, lyceums, ect) parents, teachers, civil society organization, teachers union, local buseness, private sectors, international developments partners and ect.
